- Cut-off date is June 1st to file for homestead exemption for Jefferson Parish

NOTE:

- City taxes are due January 1st for the upcoming year and are delinquent February 1st.
- Cut-off date is August 1st to file for homestead exemption for Orleans Parish
- Bills go out the second and third weeks of December.
- There are no "TOTAL EXEMPTIONS" in Orleans Parish except for certain charitable or educational organizations, if a property is assessed \$7,500.00 or under is exempt from parish tax but not for fire and police taxes.
